Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

#### Options

Therefore, the 2020-21 data between school years for the school, district, state are not an accurate comparison. ## Professional Development

Educational research supports that the most critical factor contributing to a student's success in school is the quality of the teaching. Tahoe Truckee Unified School District better ensures top-notch teaching and learning via high-quality professional development (PD.) A variety of options are available and range from formal-type workshops or seminars and informal types such as discussions among colleagues, independent reading, or observing a colleague's lesson.
