2023-24 School Safety Plan

The safety of students and staff is a primary concern of Kings Beach Elementary. All visitors to the campus must sign in at the office and wear a visitor's pass at all times. Supervision is provided to ensure the safety of each student before school, during breaks, at lunch, and after school. Supervision is a responsibility shared among support staff, teachers, and the administration. Our campus is fully gated including our Boys and Girls Club which allows our students and staff to safely move around campus and to the Club. Our site PBIS Team is working on building consistent routines among all grade levels with regard to lining up on the blacktop, walking through the hallways, and using our bathrooms. Our PBIS Team has recently piloted a behavior referral form to generate necessary data to drive what we give attention to with regard to student behavioral learning needs.

The School Site Safety Plan was most recently revised in the winter of 2023 and is currently under review by the Safety Committee. The Safety Plan is reviewed with all staff members at the beginning of each school year. Key elements of the Safety Plan focus on the following:

- School rules & procedures
- Sexual harassment policy
- Current status of school crime
- Notification to teachers
- Child abuse reporting procedures
- School wide dress code
- Policies related to suspension/expulsion
- Disaster procedures/routine & emergency drills
- Safe ingress & egress of pupils, parents, & school employees
