Dear Senior Citizen:

Thank you for your inquiry regarding the Senior Citizen's Exemption to our Measure AA tax for the 2025-2026 fiscal year.

In order to process your exemption, we will need the following:

- The Exemption Form filled out and signed by all Owners
- A copy of your original 2024-2025 property tax bill with owner's name listed on the tax bill
- Proof of age for all owners (a copy of your birth certificate or driver's license)
- A copy of the page of your trust that names you as trustee and beneficiary of a revocable trust

If your property is held in a trust, you must be the trustee and beneficiary of a revocable trust. Property held in the name of Corporations, Partnerships, and Family Trusts are not entitled to the exemption.

If you co-own the property with anyone who is not 65 as of July 1, 2025, we will prorate the exemption based on the percentage of ownership for the senior (50% ownership would be a \$74.00 exemption).

If you sell your property or make any changes to the deed, please let us know. Your exemption is automatically canceled when your deed is changed. Please call (530) 582-2594 if you have any additional questions.
